1. Page 49 & Page 50 will appear before Page 48, as these pages are not part of the financial bid. Hence, the pages will be renumbered as mentioned below & the tender will be revised accordingly:

Page 49 will become Page 48

Page 50 will become Page 49

2. On page 59, the following expression "Net Total (X) = (VIII) + (IX)" is missing from last row, first column & will be inserted. The same will be updated & will appear in the revised tender.

3. On page 60, the expression:

Due to administrative reasons, IMU-KC has decided to extend the closing date for the submission of bids up to 13/11/2018, 1130 hrs. The tender will now be opened on 13/11/2018, 1200 hrs.

5. On page 22, read the undermentioned point as insertion '33. Licence Fee'. Licence fee for main canteen is Rs. 1500 / month , for Mess is Rs. 1000 / month & for the upcoming canteen, it will be charged at Rs. 10 /Sq. mtr. per month (since the upcoming canteen's exact area cannot be ascertained at present, though it will be approx. 75 sq. mtr.).
